Biographical / Historical

Wesley Brown, born 1945, received his M.A. in Literature and Creative Writing at The City College of the City University of New York and his B.A. in History and Political Science at State University of New York, Oswego. Wesley Brown is a novelist, playwright, and teacher. He worked with the Mississippi Freedom Democratic Party in 1965 and became a member of the Black Panther Party in 1968. In 1972, he was sentenced to three years in prison for refusing induction into the armed services and spent 18 months in Lewisburg Federal Penitentiary. Brown was a professor at Rutgers University (1979-2005). He has taught literature at Bard College at Simon's Rock since 2007.

Scope and Contents

The Wesley Brown papers consists of original and photocopied material related to the writer Wesley Brown. The papers primarily contain the creative writing of Wesley Brown, including novels, plays, poems, short stories, film scripts, correspondence, and reviews related to these writings. The papers also include legal documents related to Wesley Brown's refusal to be inducted into the armed services in 1972.
