SUMMARY: This collection chiefly consists of professional and personal papers of John Archiquette that document events and activities of the Oneida Tribe of Indians of Wisconsin, primarily between 1876-1919. It also contains materials collected by his heirs, 1866-1984. The personal papers include ledger volumes that Archiquette used as journals and letter books, which include brief and frequent entries related to community affairs and events, as well as to his personal life and family. The collection also includes records of the Oneida Tribe of Indians of Wisconsin kept by Joseph O. Powless and Archiquette, which principally document deaths in the community, 1817-1880, as well as the records of the vestry council of the Church of the Holy Apostles in Oneida, Wisconsin, kept by Peter Bread and Archiquette, 1881-1906.

John Archiquette (1847-1923)

John Archiquette (1847-1923) was a prominent member of the Oneida Tribe of Indians of Wisconsin. He was a veteran of the American Civil War; a captain of the Oneida Indian police force; a vestryman and warden of the Church of the Holy Apostles in Oneida, Wisconsin; and a member of the Oneida National Brass Band.

Oneida Tribe of Indians of Wisconsin

The Oneida Tribe of Indians of Wisconsin is a sovereign nation comprised of Oneida Indians who relocated from central New York state to eastern Wisconsin in and around Green Bay from 1823 to 1841.

Holy Apostles Episcopal Church in Oneida, Wisconsin

The Holy Apostles Episcopal Church in Oneida, Wisconsin, is a mission congregation of the Episcopal Diocese of Fond du Lac founded in 1825. The church was originally named Hobart Episcopal Church for John Henry Hobart (1775-1830), the third Episcopal bishop of New York (1816-1830).

Scope and Contents

This collection chiefly consists of professional and personal papers of John Archiquette that document events and activities of the Oneida Tribe of Indians of Wisconsin, primarily between 1876-1919. It also contains materials collected by his heirs, 1866-1984. The personal papers include ledger volumes that Archiquette used as journals and letter books, which include brief and frequent entries related to community affairs and events, as well as to his personal life and family. Collection Contents Series I: Personal Papers, 1866-1984

72 Folders

This series chiefly consists of volumes kept by John Archiquette, as well as logs, correspondence, and materials collected by Archiquette and his heirs that document events and activities at the reservation of the Oneida Tribe of Indians of Wisconsin.

Series I is organized into four subseries: Diaries and Letter Books, Logs, Correspondence, Notes, and Collected Materials.

Diaries and Letter Books

Diaries and letter books kept in ledger books by Archiquette that document events and activities at the Oneida Nation of Wisconsin.

The first six volumes include manuscript transcriptions of his monthly reports to the Indian agent in his role as the head of the police force on the Indian reservation, 1876-1901. The monthly reports includes logs of life events, including births, marriages, and deaths, as well as descriptions of legal infractions on tribal land, such as cutting timber without a permit, and social transgressions, such as adultery. The volumes include transcriptions of other official and personal correspondence by Archiquette.

The last two volumes were kept by Archiquette during his retirement, 1906-1919, The volumes include logs of life events, as well as records of his daily activities and transcriptions of his personal correspondence. There is also a fragment from a volume, which documents his activities in September and October 1910, as well as his financial disbursements in March 1910.
