Founded in 1701, Yale College was a place “wherein Youth through the blessing of Almighty God may be fitted for Publick employment both in Church and Civil State.” In 1822 the Divinity School became a separate school within the University and now is one of eleven graduate and professional schools, which, with the College, comprise Yale University. Yale University Divinity School provides three degree programs: the Master of Divinity, the Master of Arts in Religion, and the Master of Sacred Theology.
