## Biographical / Historical

The Seward family belong to the group of families that settled in Connecticut during the 17th century. One of the most prominent members of the family was William Seward, born on July 27, 1712, in Durham, Connecticut. Around 1730, as William began his studies at Yale College, the family moved to Guilford. William studied theology and became a Congregationalist minister in Killingworth, where he preached for 44 years, until his death on February 5, 1782. William's eldest son, William, was born on November 19, 1747, graduated from Yale in 1769, and also became a Congregationalist minister. Following his death on July 5, 1822, his service during the Revolutionary War, where he appears to have served as chaplain, was duly noted. Another of William, Sr.'s sons, named John, completed coursework for the Yale College class of 1784, but died of scarlet fever before commencement. He, like his father and brother, had intended to enter the ministry.
