Biographical / Historical

Thomas Francis Gilroy Daly, known as T. F. Gilroy Daly, was born on February 25, 1931, in New York City. He received his B.A. from Georgetown University in 1952. Daly served in Korea in the U. S. Army Rangers from 1953 to 1955 and attained the rank of first lieutenant. After completion of military service, Daly went to Yale Law School where he obtained his J.D. in 1957 and received the John Fletcher Caskey Prize for outstanding performance in a moot court trial.

After graduation, Daly practiced law in Washington, D.C., for five years. He then served as an assistant United States attorney for the Southern District of New York from 1961 to 1964. Daly practiced law in Connecticut from 1964 to 1977. In addition to his practice, he held several positions in Connecticut government: deputy state attorney general from 1967 to 1971, special assistant to the state attorney general from 1971 to 1975, deputy state treasurer from 1975 to 1976, and state insurance commissioner from 1976 to 1977.

Daly gained prominence in the 1970s for his pivotal role in obtaining freedom for Peter Reilly. In 1974, Reilly, aged eighteen, was convicted of manslaughter in the stabbing death of his mother. The conviction was largely based upon Reilly's confession, which his supporters maintained was the product of police coercion. After his conviction, Reilly's supporters convinced Daly to enter the case and appeal the conviction. It was discovered that the prosecutor, now dead, had not disclosed exculpatory evidence to Reilly's attorney. After a six-week hearing, Reilly was released from prison and the charge was dismissed.

Daly was nominated by President Jimmy Carter to serve as a United States District Court judge for the District of Connecticut in 1977. He served on the Court until his death in 1996. He was chief judge of the District of Connecticut from 1983 to 1988.

T. F. Gilroy Daly died on July 11, 1996, and was survived by his wife, Stuart Stetson Daly, and their four children, Timothy, Loan, Matthew, and Anna.

Scope and Contents

The papers consist of correspondence, continuing education course materials, legal pleadings, memoranda, newspaper clippings, photographs, reports, subject files, and writings that document T. F. Gilroy Daly's career as a United States District Court judge. The papers provide a comprehensive overview of Daly's career from his appointment in 1977 until his death in 1996. There are no materials relating to the Peter Reilly court case.

The T. F. Gilroy Daly Papers were processed as a collaborative effort between Manuscripts and Archives and the Yale Law School to document the careers and accomplishments of Law School faculty and alumni.

Collection Contents

Series I: Judicial Agencies and Activities, 1966-1996

This series includes correspondence, memoranda, newspaper clippings, photographs, reports and other materials created or collected by T. F. Gilroy Daly and relating to various judicial agencies, organizations, and individuals. The majority pertain to federal judicial activities, particularly from administrative agencies such as the Administrative Office of the United States Courts (AOUSC) and from individuals and departments within the Connecticut federal court system. Daly's original filing system, in which materials were filed by the name of the organization, office, or topic, has largely been retained.

Significant amounts of material document the response of the federal judiciary to crises involving class action suits, alternative dispute resolution methods, criminal sentencing, and increasing number of civil and criminal cases. Also illustrated in the Connecticut District Court files are the wide-ranging administrative responsibilities that Daly had, in addition to his regular caseload, when he served as chief district court judge between 1983 and 1988.

Correspondence with other district court judges and court officials is largely routine. Congressional correspondence is dominated by repeated requests for additional federal judges for Connecticut and responses by the judiciary to legislative proposals. General correspondence is also largely routine and includes notes and invitations to and from various judicial and political officeholders and letters from the public commenting upon Daly's decisions. Correspondence from prisoners generally includes requests for assistance in obtaining new hearings or trials, improved prison facilities, transfers to other locations, or relief from alleged abuse by prison staff. Also noteworthy are letters, newspaper clippings, and other items exchanged between Daly and his law clerks after the completion of their clerkships.
