**SUMMARY:** The American Field Service Application Records comprise the history of an application filed in 1990 by American Field Service veterans of World War II for retroactive recognition as United States Army servicemen by the Pentagon under provisions of the G.I. Bill of 1977. The collection also contains research materials and publications relating to the history of the American Field Service during both world wars. The records, comprised of original documents, as well as photocopies thereof, were amassed by Joseph Porter Brinton, III, an ambulance driver with the American Field Service during World War II, who compiled the guide for their use.

### **Processing Information**

Folders within the collection were retained whenever possible and provide copious notes, written by the donor, about their contents. The contents of these original folders were not verified against the label and notes written on the folders. Materials that were received unfoldered were foldered during processing by Manuscripts and Archives staff, and materials were reboxed for preservation purposes. The descriptions of the contents of each original box provided in this finding aid is excerpted from the donor's summary. Engaging with the guide (in Box 13, folder 1 of the original accession) compiled by the donor is a crucial first step for any researcher wishing to use these records. Books, journal articles, and other printed ephemera are listed at the end of the inventory for the first accession but are not arranged in any way.

## **Biographical / Historical**

Joseph Porter Brinton, III, was a member of Yale College, Class of 1945W. He received a BBA from Baruch College City University, New York, in 1957. Brinton was an ambulance driver with the American Field Service during World War II.

The American Field Service was established in 1914 as a volunteer ambulance corps. Its members, largely recruited from American colleges and universities, served in wartime Europe, primarily France.

### Scope and Contents

The American Field Service Application Records comprise the history of an application filed in 1990 by American Field Service veterans of World War II for retroactive recognition as United States Army servicemen by the Pentagon under provisions of the G.I. Bill of 1977. The collection also contains research materials and publications relating to the history of the American Field Service during both world wars. The records, comprised of original documents, as well as photocopies thereof, were amassed by Joseph Porter Brinton, III, an ambulance driver with the American Field Service during World War II, who compiled a guide for their use.

### Arrangement

The materials are arranged in three parts and one addition: I. Main business file (original box designation B), II. Main writing file (original box designation E), and III. Boxed volume files (original box designation VB). Within these parts, the materials are arranged as received from the donor. The donor's original box designations have been preserved in the inventory of the collection, and the donor's summary of the contents of each original box (with the exception of the VB boxes) is in the first folder within the original box designations.

## **Collection Contents**

This guide explains the organization imposed by Brinton on the Main business file (B), Main writing file (E), and Boxed volume files (VB) components of the archive. Researchers wishing to use the archive should consult the guide as a preparatory step.

b. 1, f. 1-91	B1 This box contains earliest records of PL 95-202 applicants from 1981-1983. The first writing at the back of the box probably commenced in 1982. Content of missing papers can usually be deduced from adjacent records. The subjects include attempts to notify a disinterested and hostile AFS Corp., improper attorney report disowned by source, effort to obtain a current veterans address list, devious obstruction by Corp. Secretary R. Applewhite, test mailing to AFS veterans, report of results. No record was kept of unanswered notes to Corp. leader A. Howe. The extensive phone and in-person dealings with Applewhite were not recorded by us. The front of the box likely overlaps to a large extent with the content of B2 and perhaps B3. b. 1, f. 92-117	B2 Activity from first major mailing in February 1985 until the Department of Defense suspended PL 95-202 applications in 1988 and posted new regulations in 1989. Affiliation with AFS Corp. through Howe and Applewhite and creation of the AFS Veterans Committee in final form is covered, along with problems and dealings related to writing a PL 95-202 application. B2 contains a very large amount of historical research data and notes. Written research notes are very much curtailed because the researcher (Brinton) was forced to photocopy information, maps, and photographs to save time, rather than read carefully and write notes. In addition, the back of the box contains a continued collection of folders devoted to individual AFS veterans leading the application or contributing to it. Box VB6 was distributed to libraries noted above. Box VB2 contained an exact duplicate copy of the contents of Box VB1 and was discarded.
