SUMMARY: The papers consist of correspondence, legal papers, notes, and other materials documenting Weinberger's career as a lawyer who specialized in civil liberties cases and, later in his career, copyright law. The one hundred and sixteen (116) case files include legal briefs, writs, and memoranda prepared by Weinberger and his staff, and similar material prepared by opposing attorneys. Correspondence files include letters with clients and individuals interested in a specific case. Weinberger's clients included: Alexander Berkman, Grover Cleveland Bergdoll, Emma Goldman, and Eugene O'Neill. The papers also include a small number of Weinberg's short stories and plays and correspondence with his nephew, Warren Weinberger.

Biographical / Historical

Harry Weinberger was born in New York City in 1888. He attended New York University and was admitted to the bar in 1908. A staunch believer in civil liberties, Weinberger defended many aliens, immigrants, anarchists, and other radicals, including Emma Goldman and Alexander Berkman, whom he believed had been deprived of their rights. He also developed an expertise in copyright law, representing many writers, including Eugene O'Neill. Weinberger died in 1944.

Scope and Contents

The papers consist of correspondence, legal papers, notes, and other materials documenting Weinberger's career as a lawyer who specialized in civil liberties cases and, later in his career, copyright law. The one hundred and sixteen (116) case files include legal briefs, writs, and memoranda prepared by Weinberger and his staff, and similar material prepared by opposing attorneys. Correspondence files include letters with clients and individuals interested in a specific case. Weinberger's clients included: Alexander Berkman, Grover Cleveland Bergdoll, Emma Goldman, and Eugene O'Neill. The papers also include a small number of Weinberg's short stories and plays and correspondence with his nephew, Warren Weinberger.

The Harry Weinberger Papers cover Weinberger's professional career from around 1915 until the early 1940s. In that time, Weinberger handled many types of cases, but he took a special interest in people

whom he believed had been deprived of their civil liberties. As a result, Weinberger defended many aliens, immigrants, anarchists, and radicals. Two of Weinberger's most celebrated clients were the anarchists Emma Goldman and Alexander Berkman. Another client of Weinberger was the wealthy draft dodger, Grover Cleveland Bergdoll. Most of Weinberger's clients were, however, neither famous nor wealthy. Many were referred to Weinberger by service agencies like the American Civil Liberties Union, the League for Amnesty of Political Prisoners, and the Worker's Defense Fund.

In the later part of his career, Weinberger became an expert in copyright law, representing many writers, including Eugene O'Neill, in copyright and plagiarism suits. Weinberger corresponded with many prominent figures in connection with his legal work. His correspondents include Roger N. Baldwin, William A. Black, Alice Stone Blackwell, Harry M. Daugherty, Albert DeSilver, Elizabeth G. Flynn, Agnes Inglis, Daniel Kiefer, Robert M. LaFollette, Alvaro Obregon, Elmer Rice, Upton Sinclair, Lincoln Steffans, Norman Thomas, Frank P. Walsh, Thomas E. Watson and Stephen S. Wise.

The papers provide information on United States policies toward aliens, anarchists, and radicals in America during and after the first World War. The papers also contain material on United States immigration and deportation policies and important materials on Emma Goldman, Alexander Berkman, Ricardo Flores Magon, and Tom Mooney. There is, however, very little personal material on Weinberger in the papers. Biographical information can be found in Weinberger's "A Rebel's Interrupted Autobiography" published in the American Journal of Economics and Sociology in 1 October 1942.

The main accession is arranged in alphabetical order according to name of client. Two additions are arranged alphabetically by type of material.

Collection Contents

Original accession, 1915-1943

Abels, Samuel

The papers consist of letters and legal papers concerning *New York vs. Samuel Abels*, 1917. Abels was arrested, tried, and convicted for desecration of the flag. Weinberger appealed the conviction to the New York Supreme Court, alleging there was no violation of law, merely an expression of opinion. The lower court ruling was affirmed.

Abrams, Jacob

The papers consist of letters, legal papers, notes, and miscellaneous papers concerning the cases: *United States vs. Jacob Abrams et al.*, *United States vs. Gabriel Prober et al.*, and *Jacob Abrams et al. vs. United States*, 1918-1921.

Jacob Abrams, Hyman Lachowsky, Samuel Lipman, Gabriel Prober, Hyman Rosansky, Jacob Schwartz, and Mollie Steimer were admitted anarchists charged with violating the wartime Espionage Act. The defendants had distributed pamphlets denouncing American intervention in Russia in 1918 as contrary to the best interests of the Russian people. Prober, Schwartz, and Rosansky were dropped from the case, leaving the "Four Russians" - Jacob Abrams, Hyman Lachowsky, Samuel Lipman, and Mollie Steimer. Weinberger was attorney for the accused, and after their conviction in 1918, he unsuccessfully sought to obtain executive clemency. The "Four Russians" were deported to the USSR in 1923. Interest in this case was widespread, due in large part to Weinberger's efforts in publicizing the impact of the trial and the convictions on the civil liberties of the individual. This section includes letters from many prominent Americans expressing their opinions on this case.

Becker, Morris

The papers consist of letters, legal papers, and miscellaneous papers concerning *United States vs. Morris Becker*, 1918-1920. While serving a term in the United States Penitentiary in Atlanta, Becker refused to register for the draft. Upon his release he was re-arrested by the Department of Justice and held for deportation by the Department of Labor as an anarchist. Weinberger got the Selective Service violation dismissed and Becker was deported to Russia with Emma Goldman and Alexander Berkman in December 1919.

Bergdoll, Grover C.

The papers consist of letters, legal papers, notes, clippings, and miscellaneous papers. Weinberger's association with Grover Cleveland Bergdoll spans more than twenty years. Bergdoll, World War One's most infamous draft dodger, was court-martialed in 1920 and sentenced to five years confinement. Weinberger served as his attorney. In May of 1920, Bergdoll escaped and fled to Germany where he married and raised a family.

In 1939, Bergdoll voluntarily returned to the United States. He was taken into custody by military authorities and was tried and convicted for escape and desertion. Weinberger again served as attorney. Weinberger also aided Bergdoll in other matters. He arranged the return of large amounts of Bergdoll's property that had been seized by the Alien Property Custodian. He also lobbied against a bill sponsored by Representative Forest A. Harness that would have prevented Bergdoll's return to the United States.

Relations were not always cordial between Weinberger and his client. Conflict over Weinberger's dealings with the Alien Property Custodian prompted Bergdoll to discharge Weinberger in 1939. Weinberger brought suit against Bergdoll in 1940 to collect fees he claimed were due him.

Legal papers

The legal papers, notes, clippings, and miscellaneous papers are arranged into several general sections as follows: A) Draft/ first court-martial, B) New habeas corpus, C) Second court-martial/ appeal, D) Alien property, E) Harness bill, F) Harry Weinberger vs. Bergdolls, and G) Newspaper and magazine clippings.

These seven sections contain overlapping and related materials and are not rigid, separate files.

A) Draft/ first court-martial: This section contains material on Bergdoll's arrest for desertion, the habeas corpus proceeding, and the 1920 court-martial.

B) New habeas corpus: Upon his voluntary return to the United States in 1939, Bergdoll was held by military authorities. New habeas corpus proceedings were begun in 1939. These papers concern the new habeas corpus, the appeals to the Circuit Court, and, after denial there, to the Supreme Court. The petition for the writ of certiorari was prepared by Weinberger though he was no longer attorney in the case. Also filed with these papers are some documents relating to the original habeas corpus proceedings.

C) Second court-martial/ appeal: This section contains materials used in Bergdoll's second court-martial.

D) Alien property: This material concerns Weinberger's attempts to recover property of the Bergdoll family confiscated by the Alien Property Custodian.

E) Harness bill: This section contains miscellaneous pamphlets, notes, and statements relating to Weinberger's activities in opposition to a bill introduced by Representative Forest A. Harness that sought to exclude from the United States persons convicted of desertion from the military while the United States is at war.

F) *Harry Weinberger vs. Bergdolls*: In 1940, Weinberger brought suit against Grover Cleveland Bergdoll and his wife in an attempt to collect money due him as fees for his services as attorney. The case was settled out of court. Included in this section are early agreements and retainers.

Bosco, Paul

The papers consist of letters, legal papers, and miscellaneous papers concerning *United States vs. Paul Bosco*, 1919-1921. Bosco was convicted for distributing a pamphlet entitled "The Price We Pay" and sentenced to two years in the Atlanta Penitentiary. Upon his release, Bosco was held for deportation as an anarchist. Sponsored by the Workers' Defense Union and the American Civil Liberties Union, Weinberger requested a reopening of the case on the basis of additional evidence. The arrest and deportation warrants were eventually cancelled. This case aroused widespread discussion of the rights of aliens. Included in these papers are Weinberger's replies to the attack on him by the American Legion and to Congressman Albert Johnson's speech "Alien Anarchist Set Free."

Goldman, Emma

The papers consist of letters, legal papers, notes, clippings, and miscellaneous papers. Weinberger was a close friend and advisor of the noted anarchist and radical Goldman. He represented her in several court cases and in some business matters. Weinberger was also an advisor of Goldman's associate Alexander Berkman. Material relating to both Goldman and Berkman is filed in this section.

Weinberger's relationship with Goldman spanned more than twenty years. He defended her in 1916 against a charge of distributing literature relating to birth control. In 1917, Goldman and Berkman were indicted in the United States District Court of New York for interfering with the execution of the Selective Service Act. They acted as their own lawyers, with Weinberger as an advisor. Goldman was sentenced to two years in the United States Penitentiary at Jefferson City, Missouri, and Berkman was sentenced to two years in the United States Penitentiary at Atlanta, Georgia. Charging no fee, Weinberger appealed to the United States Supreme Court on the basis that the draft law violated the thirteenth amendment. The Supreme Court declared the draft law constitutional and affirmed the convictions of Goldman and Berkman. They began their prison terms in 1918.

Weinberger corresponded with Goldman at great length while she was serving her term in the Jefferson City Prison. These letters touch on many subjects including Goldman's situation and the cases of other radicals in America. She also wrote about prison conditions and her friendship with fellow prisoner Kate Richards O'Hare.

Upon their release from prison, Goldman and Berkman, both professed anarchists, were held for deportation. Weinberger unsuccessfully tried to prove that Goldman was a citizen due to her marriage to Jacob A. Kersner. Goldman and Berkman were deported to Russia in December, 1919 on the *S.S. Buford*. They later fled to Latvia and then to Germany.

While Goldman was in exile in Germany, Weinberger attempted to straighten out a series of mishaps that had befallen her manuscript, "My Two Years in Russia." This manuscript was eventually published as *My Disillusionment in Russia* and *My Further Disillusionment in Russia*. There is extensive correspondence with Goldman, Clinton T. Brainard, and Doubleday, Page and Company in regard to these books.

Goldman, Emma (continued)

Though widely separated by her deportation, Weinberger kept in fairly close touch with Goldman. She continued to write him, informing him of her travels and her activities in the Spanish Civil War shortly before her death.

The material in this section, after the correspondence, is broken into several sections as follows:

A) Emma Goldman: This section contains legal papers relating to Goldman's book, published as *My Disillusionment in Russia* and *My Further Disillusionment in Russia*. Also filed in this section are newspaper clippings on Berkman and Goldman and copies of the newspaper serialization of *My Disillusionment in Russia*.

B) Alexander Berkman: Copies of the magazine *The Blast*, published and edited by Berkman are filed in this section.

C) *New York vs. Emma Goldman*: This section contains material relating to Goldman's 1916 trial for distributing birth control information.

D) *United States vs. Emma Goldman and Alexander Berkman*: Material relating to Goldman and Berkman's 1917 trial for interfering with the execution of the Selective Service Act is filed in this section. This includes a two volume set of the stenographer's minutes of the court proceedings. Also contained in this section are documents concerning Weinberger's attempts to prove that Goldman was a United States citizen.

E) *A. Berkman vs. The New York Produce Exchange Bank* and *E. Goldman vs. The New York Produce Exchange Bank*: Legal papers concerning the above cases are contained in this section. Weinberger charged that the bank had no right to turn over Goldman and Berkman's funds to the United States Marshall.

F) *California vs. Alexander Berkman*: This section contains material concerning the extradition of Alexander Berkman to California where he was charged with first degree murder in connection with the Tom Mooney case. Proceedings were dropped by the district attorney in San Francisco because the United States Attorney desired to retain Berkman until the case of the *United States vs. Emma Goldman and Alexander Berkman* had been decided.

Legal papers

Weinberger, whose interest in the theatre extended beyond mere legal questions, was intimately involved with the Provincetown Players and their work. He was close to founder George Cram Cook and his wife Susan Glasspell, and also to Eugene O'Neill. Weinberger was legal advisor and one of the directors of the Experimental Theatre, an organization growing out of the Provincetown Players. Papers concerning this group as well as the Provincetown Players are filed in this section.

As attorney for the Provincetown Players, Weinberger was involved in two disputes of interest. One involved the payment of the Federal War Tax on tickets. Weinberger claimed that the tax was inapplicable because the Provincetown Players was a club and not a theatre.

Weinberger successfully used the same defense when the Provincetown Players were twice charged with violating the "Sabbath law" by presenting plays on Sunday.

Rangel, Jesus M.

The papers consist of letters, notes, clippings, and miscellaneous papers.

In 1913 Jesus Maria Rangel, Charles Cline, Abraham Cisneros, Pedro Perales, Jesus Gonzales, and Leonardo Vasquez attempted to enter Mexico from Texas to take part in the revolution against Diaz. The six men were captured in a fight with Texas authorities in which a deputy sheriff was killed. They were convicted of conspiracy to murder and sentenced to the Texas State Penitentiary.

After these men had served their minimum sentences, Weinberger began to work for their release. He waged a vigorous letter-writing campaign to create a demand for their pardon. He gained support from prominent individuals and labor organizations in both the United States and Mexico. To support the request for pardons for Rangel and the others, Weinberger pointed out that they had been model prisoners and had served their minimum terms. He also claimed that there was a lack of evidence that the men had actually committed murder and that their convictions were due to anti-Mexican prejudice. In 1926, Texas Governor Miriam A. Ferguson granted full pardons to the six men.

Due to the efforts of Weinberger and others, interest in this case was widespread. Among those concerned with the release of Rangel and the others were William A. Black, Alice Stone Blackwell, Roberto Haberman, Mercer C. Johnston, Daniel Kiefer, and Alvaro Obregon.
