Immediate Source of Acquisition

Most of these financial materials were part of a collection acquired by Yale in 1922 from William H. Brown of West Haven, Conn. The collection, initially called the William H. Brown Statistical Library,

numbered some 23,000 documents and covered the years 1890 to 1917. The collection was merged with similar materials already in the University Library and later expanded by gifts from Brown and others to become what is now known as the William H. Brown Collection.
