## Victoria Sackville-West

Victoria Sackville-West, Lady Sackville, (1862-1937), was the daughter of Lionel Sackville-West, 2nd Baron Sackville and a Spanish dancer known as "Pepita de Oliva." Victoria married her first cousin, Lionel Edward Sackville-West, 3rd Baron Sackville, in 1892. Their daughter was the poet, novelist, and gardener Vita Sackville-West, who was married to British politician and writer Harold Nicolson.

## Content Description

The collection consists of correspondence, legal papers, personal papers, photographs, and artwork by or relating to Victoria Sackville-West, Lady Sackville, her daughter Vita Sackville-West, and other members of the Sackville-West family. Correspondents include Victoria's husband Lionel Sackville-West, Edwin Lutyens, Vita Sackville-West, Harold Nicolson, and Edward VII. The collection also includes third-party letters to Vita Sackville-West, Harold Nicolson, and Nigel Nicolson. The bulk of the legal papers relate to a trial concerning the Sackville-West inheritance and Knole House, the family home.
