Processing Information

Collections are processed to a variety of levels, depending on the work necessary to make them usable, their perceived research value, the availability of staff, competing priorities, and whether or not further accruals are expected. The library attempts to provide a basic level of preservation and access for all collections [as they are acquired], and does more extensive processing of higher priority collections as time and resources permit.

This finding aid, created before the advent of computer-generated files, has been converted into a ASCII data file by means of scanning and Optical Character Recognition software. While attempts have been made to retain the complete information from the original document a number of format changes have been made to present the structure of this archive in accordance with current practice.

This finding aid may be updated periodically to account for new acquisitions to the collection and/or revisions in arrangement and description.

Charles H. Mason, 1830-1859

Charles H. Mason was appointed at the age of twenty-three the first secretary of Washington Territory, and served under Governors Stevens and McMullin until his death in 1859. He served as acting governor while Stevens was in the Indian country and after McMullin returned to the East in 1858 until Governor Gholson arrived in 1859.

Scope and Contents

The papers consist of thirty-four letters, seventy-seven pages in all, written to and by Charles H. Mason. The majority of the letters relate to the beginnings of Indian hostilities in 1855. Other letters concern Fayette McMullin's attack on Mason's character in 1858.
