Processing Information

Collections are processed to a variety of levels, depending on the work necessary to make them usable, their perceived research value, the availability of staff, competing priorities, and whether or not further accruals are expected. The library attempts to provide a basic level of preservation and access for all collections, and does more extensive processing of higher priority collections as time and resources permit.

This collection received a basic level of processing, including rehousing and minimal organization. Information included in the Description of Papers note and Collection Contents section is drawn from information supplied with the collection and from an initial survey of the contents. Folder titles appearing in the contents list below are often based on those provided by the creator or previous custodian. Titles have not been verified against the contents of the folders in all cases. Otherwise, folder titles are supplied by staff during initial processing.

Sean O'Brien Strub (1958-)

Sean O'Brien Strub is an activist, author, and publisher who pioneered direct marketing and mailing techniques to fundraise on behalf of gay rights organizations and progressive Democratic politicians. He founded the direct marketing firms Metamorphics Media and Strubco in the early 1980s and formed the Strub Media Group in 1990. Strub worked mainly as a political consultant until he discovered he was HIV-positive in 1985 and turned his professional focus to AIDS activism and education. Strub was the first openly gay man to run for Congress in 1990. In 1991, he and Stephen Gendin founded Community Prescription Service (CPS), a mail-order business that filled prescriptions for FDA-approved drugs to treat HIV/AIDS and assisted patients with insurance claims; CPS also produced *Infopack*, a newsletter reporting on drug research and approvals. In 1994, Strub and Gendin launched *POZ*, a lifestyle magazine for people living with or affected by HIV/AIDS, followed by *POZ en Español* and *MAMM*, a magazine covering breast cancer. Strub was executive editor and publisher of *POZ* until 2004. As an activist, he was a longtime member of ACT-UP/New York, and in 1992 he produced "The Night Larry Kramer Kissed Me," a play by David Drake that addressed the AIDS crisis in New York in the 1980s. Strub published *Body Counts: A Memoir of Politics, Sex, AIDS, and Survival* in 2014. Publications he co-wrote include *Rating America's*

Corporate Conscience (1987) and *Cracking the Corporate Closet* (1995). Strub is currently executive director of the Sero Project, which seeks to end criminal prosecution of people living with HIV. He was also briefly president and CEO of Cable Positive, a group dedicated to raising AIDS awareness on television, and served on the board of directors of the Global Network of People Living with HIV/AIDS from 2009 to 2012.

Strub was born in Iowa in 1958 to Janey and Carl Strub, and he attended Georgetown University and Columbia University. Strub and his partner, Xavier Morales, live in Milford, Pennsylvania and New York City.

Scope and Contents

The collection consists of direct mail samples, printed material, correspondence, photographs, memorabilia and ephemera, writings, and computer and audiovisual media documenting the work and life of gay rights activist, publisher, and entrepreneur Sean Strub. Correspondents include Edward Albee, John Berendt, Richard Berkowitz, Michael Callen, Martin Delaney, Geraldine Ferraro, Ed Koch, Larry Kramer, Mathilde Krim, Torie Osborn, Vito Russo, Joseph Sonnabend, Peter Staley, Gerry Studts, Gore Vidal, Evelyn C. White, and Elie Wiesel, as well as Strub's business partner Stephen Gendin, CEO of Community Prescription Service and Executive Vice President of *POZ* Publishing. The collection contains records of Strubco and direct marketing campaigns for politicians, gay rights organizations, and HIV/AIDS activist groups; printed material, photographs, t-shirts, and other papers related to *POZ*, *POZ en Español*, *MAMM*, and *POZ* health forums; administrative and reference files for Community Prescription Service and *Infopack*; and papers concerning Strub's work on HIV decriminalization. Also present are materials related to the NAMES Project AIDS Memorial Quilt, Strub's 1990 Congressional campaign, his memoir *Body Counts*, "The Night Larry Kramer Kissed Me," and writings of Gendin and others on HIV and AIDS.

Collection Contents

Series I: Professional Papers, 1982-2013, undated

This series contains direct mail samples, printed material, correspondence, financial and legal records, photographs, and other papers documenting Sean Strub's business endeavors, fundraising, and activism, including direct marketing and list management, *POZ* magazine, and Community Prescription Service. Also included are materials concerning Strub's work against criminal prosecution of people with HIV.

Organized into four subseries: Direct Marketing, *POZ*, Community Prescription Service, and Other Papers.

Direct Marketing

This subseries contains direct mail samples, cardpacks, client files, and business records of Strubco and Metamorphics Media, Strub's direct marketing companies. Included are samples of direct mail for ACT-UP; the Boy Scouts of America; Broadway Cares/Equity Fights AIDS; the Democratic National Committee and the political campaigns of Bill Clinton, Elizabeth Holtzman, Edward Kennedy, Ed Koch, and Gerry Studds; Gay Men's Health Crisis; Gay and Lesbian Advocates and Defenders; Human Rights Campaign; National Gay and Lesbian Task Force; and Treatment Action Group. The subseries also contains materials related to Johnson & Johnson/Direct Access Diagnostics' Confide, the first home access HIV test, including correspondence, contracts, FDA advisory committee materials, research and focus group results, advertising and marketing files, and samples of the test kit.
