Correspondence and other documents by and concerning members of the Townshend family may be found by searching the finding aid for Osborn Manuscript Files. These include letters and political memoranda by Charles, 2nd Viscount Townshend (1674-1738) and Charles, 3rd Viscount Townshend (1700-1764).

## Townshend Family

The Townshends of Raynham Hall, Norfolk, England are descended from Sir Roger Townshend (d. 1493), who was a Justice of the Court of Common Pleas and served as legal advisor to the Paston family.

George Townshend, 4th Viscount and 1st Marquess Townshend (1724-1807), was educated at Cambridge and fought at Culloden (1746), retiring because of a difference with the Duke of Cumberland. During the French and Indian War, he served under Wolfe in Quebec and assumed command after the latter's death. He was Lord-Lieutenant of Ireland from 1767 to 1772, when he was recalled. He was created Marquess Townshend in 1787.

Charles Townshend, 2nd Viscount Townshend (1674-1738) was a British Whig statesman who was one of the negotiators of the Treaty of Utrecht (1713) and served as Secretary of State for the northern department under George I.
