Charles Scott (1863-1923)

Charles Scott (1863-1923) was born to Ann West Scott (1835-1909) and Robert Hall Scott (1826-1897) in Oregon.

In 1866, Robert Hall Scott purchased a flour mill and sawmill on Butte Creek in Marion County, Oregon, with his brother Thomas Scott--consequently, the village soon became known as Scotts Mills. Later, in 1897, Charles Scott, his father, and brother Robert Hall Scott (1875-1950) established the Woodburn Milling Co. in Woodburn, Oregon.

In 1916, Charles Scott served as the first mayor of Scotts Mills.

Charles Scott married Lulu A. Shaver Scott (1871-1956) in 1893. The couple had two sons, Alfred Merle Scott (1894-1977) and Charles W. Scott (1915-).

Oregon Land Company

In 1888, the Oregon Land Co. organized with Henry John Minthorn (1846-1922) as its president. In 1889, the company bought around 2,200 acres of land surrounding Scotts Mills, Oregon, previously owned by Robert Hall Scott.

The company then marketed the land to Quakers primarily from Indiana, Ohio, and Pennsylvania as an offshoot from the Quaker settlement at Newberg, Oregon.

In 1892, the company organized a Friends Colony at Scotts Mills. By March 1898, it declared insolvency and made an assignment for the benefit of its creditors to Charles Wood.
