**SUMMARY:** The collection contains black-and-white photographs by Jan van Raay documenting strikes, demonstrations, protests, sit-ins, happenings, and other events in New York City, primarily at the Museum of Modern Art (MoMA) and the Metropolitan Museum of Art. Photographs depict actions including the Art Strike against Racism, Sexism, Repression, War; the PASTA MoMA union strike; demonstrations and marches in support of the Panther 21, Black and Puerto Rican artists, and abortion rights; and The People's Flag Show, an exhibition at Judson Memorial Church organized by Guerrilla Art Action Group (GAAG) co-founders Jon Hendricks and Jean Toche, and Faith Ringgold, a Black activist and artist, who were subsequently arrested for flag desecration and became known as the Judson Three.

## Jan van Raay (1942-)

Jan van Raay is an American photographer, painter, and performance artist. She is known for photographing protests in New York City in the 1970s, as well as her portraits of public figures including Yoko Ono and John Lennon. Raay was born in Brooklyn, New York, and currently resides in Portland, Oregon.

---

## Scope and Contents

The collection contains black-and-white photographs by Jan van Raay documenting strikes, demonstrations, protests, sit-ins, happenings, and other events in New York City, primarily at the Museum of Modern Art (MoMA) and the Metropolitan Museum of Art. Photographs depict actions including

the Art Strike against Racism, Sexism, Repression, War; the PASTA MoMA union strike; demonstrations and marches in support of the Panther 21, Black and Puerto Rican artists, and abortion rights; and The People's Flag Show, an exhibition at Judson Memorial Church organized by Guerrilla Art Action Group (GAAG) co-founders Jon Hendricks and Jean Toche, and Faith Ringgold, a Black activist and artist, who were subsequently arrested for flag desecration and became known as the Judson Three.

The bulk of the collection documents the activities of GAAG, and included are copies of the group's manifestos, action scripts, open letters, internal memos, and other papers, such as letters written on behalf of Black activist Angela Davis during her imprisonment. Many photographs of protests and meetings prominently feature groups such as the Art Workers Coalition, Women Artists in Revolution, Ad Hoc Women Artists Committee, and Black Emergency Cultural Coalition. Some of the individuals pictured include Raay herself; GAAG co-founder Poppy Johnson; artists Takis, Tom Lloyd, Lil Picard, Roy Lichtenstein, Raphael Montañez Ortiz, Kate Millett, and Alice Neel; Black feminist lawyer Florynce Kennedy; attorney and American Civil Liberties Union Director William Kunstler; activist Abbie Hoffman; and MoMA Director John Hightower. Materials date from 1969 to 1974.

## Collection Contents

### Series I: Photographs, 1969–1972

14.04 linear feet (12 boxes)

This series consists of photographs by Jan van Raay documenting strikes, marches, sit-ins, protests, and other actions by artists and activist groups in New York City. A number of photographs show activities involving the Guerrilla Art Action Group and Art Workers Coalition at MoMA, such as the Art Strike against Racism, Sexism, Repression, War (Art Strike); the anti-Vietnam War "Memorial Service for Dead Babies" in front of Picasso's *Guernica*; demonstration in support of a study center for Black and Puerto Rican art at the museum; protest against New York Governor Nelson Rockefeller's response to the Attica prison uprising; and the Professional and Administrative Staff Association of the Museum of Modern Art (PASTA MoMA) strike. Raay photographed the Art Strike sit-in at the Metropolitan Museum of Art, as well as protests of the museum's planned Lehman Wing and expansion into Central Park. Also depicted are a march against New York State abortion laws; a courthouse demonstration in support of the Panther 21; and a public hearing on the question, "Are Museums Relevant to Women?" The series contains photographs of The People's Flag Show at Judson Memorial Church and organizers Faith Ringgold, Jean Toche, and Jon Hendricks, as well as meetings and rallies in support of the Judson Three after their arrest for flag desecration. Additionally included are images of performance art by Lil Picard. Most folders contain photocopied descriptions of the photographs by Jon Hendricks.

**Series II: Guerrilla Art Action Group Papers, 1974***0.42 linear feet (1 box)*

The Guerrilla Art Action Group (GAAG) was founded in New York City in 1969 by Jon Hendricks, Poppy Johnson, and Jean Toche. The group organized or participated in a number of actions in support of artists' rights, civil rights, and women's rights and in protest of the Vietnam War, censorship, corporate influence in museums, and New York State policies regarding poverty and prisons. Like the Art Workers Coalition, GAAG's goals included expanding representation of Black and Puerto Rican artists in New York museums, and the two groups often joined in demonstrations such as the Art Strike against Racism, Sexism, Repression, War. GAAG was active until the mid-1970s.

This series consists of photocopies of correspondence, manifestos, action scripts, internal memoranda, interview transcripts, press releases, open letters, clippings, and other materials pertaining to the Guerrilla Art Action Group. Included is a cover page signed by GAAG co-founder Jon Hendricks on May 16, 1974, indicating the dossier is incomplete. The papers, which date from 1969 to 1974, document the group's advocacy for artists' rights and attempts to enact museum reforms in New York, largely through protests, demonstrations, and marches at MoMA and the Metropolitan Museum of Art. The series contains materials related to an anti-war protest staged in front of Picasso's *Guernica* at MoMA, a demonstration supporting creation of a study center for Black and Puerto Rican art at the museum, and one of the group's first actions, a demonstration demanding the removal of Rockefeller family members from the MoMA board. Also documented is The People's Flag Show, an exhibition that resulted in the arrests of Faith Ringgold and GAAG co-founders Jean Toche and Hendricks. Additionally, the series contains letters written on behalf of other artists and activists, such as Jan van Raay, feminist art historian Cindy Nemser, and Black activist Angela Davis; and a copy of *Left Curve* magazine, inscribed by Toche and Hendricks.
