**SUMMARY:** The papers document Felix S. Cohen's professional career as a civil servant,

private attorney, law professor, and author. From 1933-1957, Cohen drafted legislation for the Department of Interior, most notably the Wheeler-Howard Indian Reorganization Act of 1934. In 1939 he headed the Indian Law Survey, which compiled all federal laws regarding Native Americans. He edited the summary of that survey, known as *The Handbook of Federal Indian Law*, which remains a milestone in the evolution of Indian law. Cohen continued to work for Indian and minority interests in private practice in the late 1940s

and early 1950s.

# Felix S. Cohen (1907-1953)

Felix Solomon Cohen (1907-1953) was a lawyer with special interest in natural resources, statehood and economic development for American territories, Indian affairs, immigration, and human rights. He received a B.A. from The City College of New York, an M.A. in philosophy from Harvard in 1927, a Ph.D. from Harvard in 1929, and a J.D. from Columbia Law School in 1931. From 1933 through 1947 he served in the Solicitor's Office of the Interior Department as an assistant solicitor, associate solicitor, and acting solicitor. Cohen drafted the Wheeler-Howard Act (also known as the Indian Reorganization Act) of 1934 and was named chief of the Indian Law Survey in 1939. He edited *The Handbook of Federal Indian Law* (1941), which remains a milestone in the evolution of Indian law. Cohen reentered private law practice in 1948, and handled several important pro bono cases, including lawsuits which established Native Americans' rights to vote and receive Social Security benefits in states that denied them these rights. Cohen taught at Yale University, The City College of New York, The New School for School Research and the University of Newark (later Rutgers University). He married Lucy M. Kramer in 1931, and they had two daughters. He was an active member of several political and legal organizations, including the Institute of Living Law, the National Lawyers Guild, and the Socialist Party. He died in Washington, D.C. in 1953.

# **Scope and Contents**

The Felix S. Cohen papers document the legal, academic, and scholarly career of Felix S. Cohen. The collection documents Cohen's work as a legislative draftsman and solicitor for the Department of the Interior, including the drafting of the Wheeler-Howard Act (also called the Indian Reorganization Act) of 1934 and the Indians Claims Commission Act and the conduct of an Indian law survey that eventually became *The Federal Handbook of Indian Law*. Also included are records from Cohen's time as a private attorney, when he won several significant pro bono cases establishing the civil rights of Native Americans, including Trujillo vs. Garley and Harrison vs. Laveen. Cohen's manuscript notes for the oral arguments of Trujillo vs. Garley, of which no printed record exists, are present. Also present are papers documenting Cohen's teaching career at Yale University and City College of New York, as well as his writing projects, notably *Ethical Systems and Legal Ideals*. Additional papers document Cohen's work with several political and legal organizations, including the Socialist Party and the Institute of Living Law. Finally, the collection includes personal and family papers.

# Series I: Legal Career, 1931-1953

Series consists of released office files from Cohen's years with the Solicitor's Office of the Department of the Interior (1933-47) and from his private practice (1948-53).

Organized into six subseries: Indian Affairs, Indian Law Survey, Alaska: Natural Resources and Native Affairs, Territories, Department of the Interior Solicitor's Office Records, and Private Practice Office Records.

Indian Affairs 1932–1946

This subseries contains Department of the Interior files documenting the implementation of the Indian Reorganization Act of 1934 (known originally as the Wheeler-Howard Act) and routine legal work concerning the department's Indian policies. The files consist of internal memoranda; correspondence with outside experts, other government agencies, legislators, and private interest groups; drafts of reports and legal opinions; printed bills and drafts; and printed material by government agencies and private institutions. The files also contain articles written by Cohen, with supporting documentation, connected with his work for the department.

The material documents aspects of Cohen's legal career as a civil servant, private attorney, and author, as well as his social, political, and professional activities and personal and family life. Included in the addition are files stemming from Cohen's work as a legislative draftsman and solicitor for the Department of the Interior, relating especially to Indian affairs and natural resources, including the drafting of the Wheeler-Howard Act and the Indian Claims Commission Act. Also included are papers concerning his work as a private attorney after he left government service in 1947, relating to Indian affairs, immigration, and voting rights, including his manuscript notes for oral arguments in the cases of Trujillo vs. Garley and Harrison vs. Laveen (1948). It also includes files relating to Cohen's various writing projects, including Ethical Systems and Legal Ideals (1933) and The Legal Conscience (1960); and extensive files stemming from his activities with the Socialist Party and the National Lawyers Guild and other social, political, and legal organizations (circa 1930-1940), including the League for Industrial Democracy and the Institute for Living Law. Also present are some personal and family papers.

The addition consists of material that was stored in the basement and other areas of the Cohen residence in Washington, D. C. and that came to light after the death of Lucy Kramer Cohen in 2007.

The addition was first processed in 2007-2008. It initially received a separate finding aid with the call number WA MSS S-2602. Arrangement was largely carried out in accordance with how the initial collection (Felix S. Cohen Papers, WA MSS S-1325) was arranged. Files arrived with no discernable order and extensive re-organization was required to arrange files into series and subseries. Descriptive information at the file level is based on a basic survey of the folder contents. Descriptive information about the collection as a whole was drawn in part from the finding aid for the Felix S. Cohen Papers, WA MSS S-1325. The two collections (WA MSS S-1325 and WA MSS S-2602) were reprocessed and combined in 2019, retaining the earlier call number.

Legal Career 1930–1955

The Legal Career subseries consists of files stemming from Cohen's work with the Solicitor's Office of the Department of the Interior from 1933 to 1947, with his private practice from 1948 to 1953, and Cohen's early legal career, including law school.

The Legal Career subseries is arranged into four groupings: Indian Affairs, Department of the Interior Solicitor's Office Records, Private Practice Office Records, and Other Professional Papers.

Indian Affairs 1930–1942

Concerns the Department of Interior files largely documenting the drafting and implementation of the Indian Reorganization Act of 1934 (IRA, known originally as the Wheeler-Howard Act), a 1939-1940 survey of Indian Law that resulted in the publication of The Handbook of Federal Indian Law, and routine legal work concerning the department's Indian policies. The files consist of internal memoranda, correspondence, drafts of reports and legal opinions, printed bills and drafts, and printed material by government agencies and private institutions.
