This collection received a basic level of processing, including rehousing and minimal organization. Information included in the Description of Papers note and Collection Contents section is drawn from information supplied with the collection and from an initial survey of the contents. Folder titles appearing in the contents list below are often based on those provided by the creator or previous custodian. Titles have not been verified against the contents of the folders in all cases. Otherwise, folder titles are supplied by staff during initial processing.

This finding aid may be updated periodically to account for new acquisitions to the collection and/or revisions in arrangement and description.

Gordon family

The Gordon family of Gordonstoun, Moray, Scotland, are part of Clan Gordon from Aberdeenshire. The chief of the clan is the Marquess of Huntly, earlier the Earl of Huntly. George Gordon (1514-1562), 4th Earl of Huntly, married Elizabeth Keith, and they had 12 children including George Gordon, 5th Earl of Huntly (-1576) and Lady Jean Gordon, Countess of Bothwell (1546-1629). Jean Gordon married Alexander Gordon, 12th Earl of Sutherland. Their children included Robert Gordon (1580–1656), a Scottish politician who acquired properties in the shires of Elgin and Forres that were united into the barony of Gordonstoun by charter in 1642. Gordon married Lucie (or Louise) Gordon (1597–1680), and their children included Lodovick (or Ludovick) Gordon (1614–1685), a member of parliament for Elgin & Forresshire, who married Elizabeth Farquhar, daughter of Sir Robert Farquhar of Mounie; and Katherine Gordon (1621–1683), who married Colonel David Barclay. Katherine and David Barclay's son Robert (1648-1690) was a writer belonging to the Religious Society of Friends and titular governor of the East Jersey colony in North America. The Gordonstoun baronetcy passed from Ludovick to his son Robert (1647–1704), grandson Robert (1696–1772), and great-grandson William, who died in 1795 and was succeeded by Alexander Penrose Cumming Gordon (1749-1806) of Altyre. Other members of the family included George Gordon (1643-1716), 4th Marquess of Huntly and 9th Earl of Huntly, who was created Duke of Gordon in 1684.

Scope and Contents

The collection contains correspondence, legal documents, deeds, and other papers by or relating to the Gordon family of Gordonstoun and Cumming family of Altyre, Scotland. Correspondents include George Gordon, Robert Gordon, Alexander Penrose Cumming Gordon, Robert Farquhar of Mounie, Thomas

Urquhart of Cromarty, King Charles I, King James I, and Oliver Cromwell. Topics of letters and papers are the Jacobite army and support for the rebellion in 1745-1746, smuggling off the coast of Scotland in the 1740s, the Napoleonic Wars, land investment in Scotland and Jamaica, and British colonization of India. The collection also contains passports issued by Charles I and King Louis XV of France.

Collection Contents

Series I: Correspondence, 1614-1831

0.63 linear feet (2 boxes)

This series largely consists of business and personal correspondence of the Gordon, Cumming, Farquhar, and Urquhart families. Among the topics of letters are smuggling on the Scottish coast, demands by the Jacobite army on Robert Gordon (1696-1772), administration of Alexander Cumming's estate in Jamaica, the Napoleonic Wars, and Great Britain's colonization of India in the 1800s. Correspondents include Robert Gordon, John Gordon, Robert Farquhar, Robert and Thomas Urquhart, King Charles I and King James I of England, and Oliver Cromwell, as well as Scottish slave trader and Jacobite supporter Evan Baillie.
