Susan Cole

Susan Letzler Cole (1940-) is an American educator and author. Born in Washington, District of Columbia, Cole graduated with a Bachelor of Arts degree from Duke University in 1962. She then attended Harvard University, where she received her Master of Arts in 1963 and a Doctor of Philosophy degree in 1968. Her notable works include *The Absent One, Directors in Rehearsal: A Hidden World*, and *Playwrights in Rehearsal: The Seduction of Company*. Cole is a professor of English at the Albertus Magnus College in New Haven, Connecticut.
