This finding aid was revised in 2021 to address outdated or harmful descriptive language. During that revision, description was changed in the collection level scope and contents note. References to Japanese American "relocation," "evacuation," and "internment" during World War II were removed and replaced with community recommended/currently accepted terminology in 2021, such as "Japanese American incarceration." Yonekazu Satoda (born 1921)

Yonekazu "Yone" Satoda was born in Hanford, California in 1921, a son of Otokichi "Fred" Satoda (1885-1968), originally from Hiroshima, Japan, who immigrated to the United States in 1902, and Asano Satoda (1894-1990), who immigrated to the United States from Japan in 1920. He had two siblings, Fumiye Satoda (later Yeabisu) (born 1922) and Masaharu Satoda (born 1924).

Satoda graduated from University of California in 1942, the same year that authorities sent him to the Jerome Relocation Center in Denison, Arkansas. In February 1945, the United States Army drafted

Satoda. He received basic training at Camp Hood, Texas, and attended Officer Candidate School at the Infantry School at Fort Benning, Georgia, as well as Military Intelligence Service Language School at Fort Snelling, Minnesota. From November 1946 to August 1948, Satoda served as a first lieutenant and military intelligence officer in Tokyo and Hokkaido, Japan. After discharge from the active duty, Satoda served in the United States Army Reserves from 1949 to 1969; he retired as a major.

In March 1961, Satoda married Taka "Daisy" Uyeda (born circa 1928) and they had three children. Satoda worked as an accountant and lived in San Francisco, California.

Scope and Contents

This collection includes papers, photographs, and moving films that document the incarceration of Yonekazu Satoda, a Japanese American man, at the Jerome Relocation Center in Arkansas, 1942-1945, as well as his military service with the United States Army in Japan, 1946-1948. Additional material documents other aspects of his life, especially his education as an accountant, as well as correspondence with friends and businesses.

Material related to his incarceration at the Jerome Relocation Center includes a diary he kept from May 1942 to February 1945, as well as photographs that document the camp and his family.

Material related to his military service includes training information from Officer Candidate School at the Infantry School at Fort Benning, Georgia, as well as photographs and moving films created during his service in Japan
