SUMMARY: The papers of Lieutenant-General Thomas Fowke of Park Hill, near

Sheffield in Yorkshire, cover the decade 1746 to 1755, with half of the material concerning his term as Governor of Gibraltar (1753-1755). The collection contains approximately 500 letters, documents, and official and personal papers including copies of many of Fowle's outgoing letters. The correspondence is with business colleagues in England and Ireland primarily involved in real estate transactions, with military officers and those who wanted to enter service, and with officials of the British government and local governments near Gibraltar, particularly in Spain and Morocco. Also present is a small manuscript map, likely drawn as an exercise by a trainee

military engineer.

Custodial History

No provenance information was provided by the auction house but a twentieth-century printed genealogical pamphlet with a biography of Sir Frederick Ferrers Conant Fowke (1879-1948), Bt., of Lowesby Hall, was laid in the first volume, and likely indicates a custodial chain. The pamphlet was added to the library's collection file for the papers.

Processing Information

The Thomas Fowke Papers were received at the library in two volumes which were described in the auction listing as "over 500 items, many papers folded to fit the volumes, some fraying at outer edges, dust-staining, tears along folds etc., contemporary sheep-backed boards, spines defective, worn," which did not adequately describe their condition. Many of the larger documents were missing up to an inch of their outer edges, many others were torn and broken along fold lines, and there was only partial chronological order within the two volumes, which were advertised as dating 1753 (first volume) and 1755 (second volume). When the material was removed from what was left of the bindings, flattened, and foldered, it was discovered that the collection spans an entire decade from 1746 through 1755, and the contents were mixed, with both personal and governmental/military topics covered in each volume.

Thomas Fowke (1690-1765)

Thomas Fowke was born in 1690, the son of Thomas Fowke (1645-1708) and his second wife Mary (1650-1705) of Gunstone, South Staffordshire, England. He was married twice, first in 1721 to Elizabeth Ingoldsby (1705-1735), daughter of William and Theophila Lucy Ingoldsby, and then in 1741 to Dorothea Randall (1704-1784), daughter of Edward Randall of Salisbury, Wiltshire. Fowke he had three children, Theophila Lucy (1724-1734), Sir Thomas Fowke (1744-1786), and Theophila (1745-1756).

Fowke's military career spanned 1702 through his appointment as governor of Gibraltar in 1752. Following the British Navy's defeat at Minorca in June 1756, Fowke was courtmartialed, charged with refusing to provide Admiral John Byng with reinforcement from the garrison at Gibraltar, and dismissed from the Army. Fowke was reinstated to the rank of general in 1761 and died in Bath, Somerset, on March 29, 1765; he was buried at Bath Abbey.

Scope and Contents

The papers of Lieutenant-General Thomas Fowke of Park Hill, near Sheffield in Yorkshire, and London, cover the decade 1746 to 1755, and half of the material concerns his term as Governor of Gibraltar (1753-1755).

The collection contains approximately 500 letters, documents, and official and personal papers including copies of many of Fowle's outgoing letters.

While only focused on a few years of his life, primarily 1735 to 1755, the papers provide details about his operations, agents, and governmental colleagues, as well as the constant need for intelligence about the movement of ships, both naval and merchant, between England and Europe. Organized into two series, the first holds material related to Fowke's personal life, assets, and activities in England and Ireland. The second series covers his life in Gibraltar and is predominantly dated in 1755. While not giving a full picture of his reign as Governor, the papers provide evidence of some of the military, political and diplomatic concerns he faced while there.

The Thomas Fowke papers contain no family correspondence with the exception of two letters from his son Thomas, while a student in Geneva. Also present is an invoice in the folder for Theodore Desvories, who handled Thomas's arrangements there. Desvoires is one of several Huguenot refugees who emigrated to Ireland and appear the Thomas Fowke Papers.

Arrangement

Organized into two series: I. Personal Papers, 1746-1755. II. Diplomatic and Military Papers, 1750-1755.

Collection Contents

Series I: Personal Papers, 1746-1755

Series I contains letters and documents related to Fowke's personal activities in England and Ireland, in particular those involving his real estate in South Yorkshire where his estate, Park Hill, was located just outside Sheffield. The full story of his life there is not encompassed in the papers in this collection, but he did sell Park Hill in early 1754 as he was transitioning to his post in Gibraltar. His correspondence with local attorney William Whitaker reveals information about the management of the estate while Fowke was in London, where he also had a home, and Whitaker's folder holds a multipage inventory of the house's contents. Major William Singleton was involved in the Park Hill sale, and other real estate transactions occurred between Fowke and Thomas Threlkeld; the latter defrauded Fowke and other creditors (see Fowke's letter to Count Joseph Haslang). Other transactions are covered in the thirteen letters exchanged with Raymond Kane, an attorney in Dublin. London merchant Thomas Tierney was instrumental in arranging shipments of items including horses, fowl, wine, and a cabinet of shells, from Gibraltar to London; his folder contains a printed bill of lading along with other descriptive documents. Fowke's own household goods were also shipped and a folder of inventories and invoices for that material can be found in the Documents subseries. Other invoices and receipts in the subseries cover some of his purchases and the work done on his properties; notable are three extensive invoices for commissioned objects and services: from Elizabeth Godfrey, the leading female gold and silversmith in eighteenth-century London, from the London upholsterer Peter Des Champs, and from a scrivener, William Ward, who created and managed legal documents for Fowke in London. The folder for merchant Galfridus Mann holds a dozen letters, receipts, and other documents detailing their financial dealings.

Series I is organized into two subseries: Correspondence, and Documents.

Series II: Diplomatic and Military Papers, 1750-1755

2.75 linear feet (3 boxes)

The series holds more than half of the collection and reveals some of Fowke's administrative network of military and diplomatic contacts. The first subseries, Diplomatic Correspondence, features government officials and offices in London and British consuls stationed around the Mediterranean, and many of their folders contain more than a dozen letters. Those correspondents include Henry Fox at the War Office, Secretary of State Thomas Robinson, and naval commander George Forbes, Earl of Granard, along with Francis Aiskill in Malaga, Burrington Goldsworthy in Cádiz, and Sir Benjamin Keene in Madrid among the eight consuls found in the series. Also in the files are letters from groups of local officials in Morocco and Cádiz filed together under those places. The subseries Military Correspondence contains reports about military issues and the state of the regiments; two men making reports are Major J. Molesworth and Captain Edward Windus in Newport, both of whom wrote from Ireland. Also present are various requests for military commissions and favors as well as letters of congratulations to Fowke on his promotion to Governor. The Documents subseries holds a variety of items that were not connected to correspondence in the collection, but their content is diplomatic. The war in America, though far from Gibraltar, was of much interest to Fowke and was mentioned in some of the correspondence he received such as letters from Robert Napier and from Joseph Popham. Popham had arrived in Cádiz, having met the master of an incoming ship, told him "people of that Country were in high Spirits that our Forces were marching to the Frontiers in three different parts"). It is also highlighted in some of the four narrative reports filed here. Fowke was active in the repair of the Governors House in Gibraltar, and documentation of that project and its workers is shown in eight detailed invoices. One other item, the Order of Session of the Peace, exposes the physical conditions of the town of Gibraltar and a set of decisions made to improve it.
