Biographical / Historical

George Gaddis Smith, mostly known as Gaddis Smith, was born December 9, 1932, in Newark, New Jersey and lived his early life in Summit, New Jersey where he attended and graduated Pingry School in 1950. Smith married Barclay Manierre in 1951. He attended Yale College and served as the Chairman for the *Yale Daily News* in 1953. He graduated from Yale College in 1954. He spent the next seven years teaching and pursuing his PhD in history at Duke University and returned to Yale to teach in 1961. He became Head (title formerly known as "Master") of Pierson College in 1972; he served in the position for nine years working closely with Yale President Kingman Brewster. Throughout the 1980s he taught courses on American history and

foreign policy. Some of his students from this time went on to become public figures in the entertainment industry and US politics.

Smith published a variety of journal articles, opinion pieces, and academic books on American history, specifically cold war history and US foreign policy in the 20th century. At Yale, he chaired the Department of History and was the Director for Yale Center for International and Area Studies. In 2001, he began teaching a course on Yale University history and the US. This formed the basis of his book on the history of Yale University, published in 2023. Gaddis Smith passed away in his home from progressive supranuclear palsy in New Haven, CT on December 9, 2022.

Scope and Contents

Collection consists of personal and travel diaries, academic writings, short story drafts, research and lecture notes, and correspondence. Topics covered in the collection are Gaddis Smith's early life, living in New Haven, marriage and family, aging, hobbies, running and fitness, archival and general research, attending Yale and Duke University, work at Yale University as a professor, chair of the Department of History, and directorship of the Yale University MacMillian Center for International and Area Studies (formerly known as Yale Center for International and Area Studies), international travel and politics, Iraq War, 9/11, Vietnam War protesting and arrest records, maritime history of US Great Lakes region and Atlantic Ocean, and Yale Alumni associations.

Arrangement

The Gaddis Smith papers are organized into three series: I. Diaries and correspondence, 1919-2014. II. Public talks and lectures, 1977-2007. III. Writings, 1972-2004.

Collection Contents

Series I: Diaries and correspondence, 1919–2014

Majority diary entries, newspaper clippings, and correspondence to and from family members and colleagues dispersed throughout series. Diary entries cover Smith's early life, educational career, personal and professional life in New Haven, CT, international politics, travel, hobbies, aging, and reflections on major world events.
