Sandra Berrigan (1942-)

Sandra "Sandy" Berrigan née Alper was born in 1942 in Detroit, Michigan. At age 13, her family moved to Miami, Florida where her father, Louis Alper, was a practicing physician.

Berrigan attended Sophie Newcomb College in New Orleans where she met Dick Gallup, a student at Tulane University. In February 1962, Gallup introduced Sandy to his friend visiting from New York, Ted Berrigan (born Edmund Joseph Michael Berrigan Jr.). The two quickly fell in love and, within a week, Sandy and Ted got married in Houston, Texas. The newlyweds agreed to visit Sandy's parents in Miami and a few days later Louis and Dorothy Alper obtained a court order to commit Sandy to the Jackson Memorial Hospital's mental ward. Sandy was held in the hospital from February to May 1962, during which time she and Ted exchanged numerous letters full of poetry and philosophical discussion. In early May, Sandy was allowed to visit the public library on good behavior. Ted was waiting for her there and together they fled Miami eventually landing in New York City.

In June 1962, the Alpers again had Sandy committed first at Bellevue's mental ward and then later at the Euphrasian Girls' Home. She was released on July 26, 1962. Sandy and Ted remained married for the next seven years, had two children, and then separated in 1969. During this time Sandy met other poets and writers in Ted's circle including Ron Padgett, Tom Veitch, and Joe Brainard. This is also the period when Ted is working on his most famous book, The Sonnets (1964). Sandy eventually moved California, raised her two children, and continued to correspond with the poetry community she had become a part of. She wrote and collaborated on poetry of her own and in 2010 she co-edited -- with Ron Padgett -- the collection of the letters she and Ted sent to each other in 1962 into the book, *Dear Sandy, Hello*.

Scope and Contents

The Sandra Berrigan Papers consists of her personal and literary correspondence, as well as realia related to Sandra Berrigan's life and work as a writer and poet. The correspondence captures Berrigan's many decades long friendships with poets and creatives in and around the second generation of the New York School of poets including Ron Padgett, Dick Gallup, Anne Waldman, Joe Brainard, and Maureen Owen.

Included in the correspondence are Berrigan's original letters she exchanged with her former husband and poet, Ted Berrigan. These letters were written in 1962 while she was held at the Jackson Memorial Hospital mental ward--at the behest of her parents--during the beginning of the Berrigans' marriage. Also included in this collection are drafts of the book *Dear Sandy, Hello* and three poetry quilts Sandra created by incorporating pieces of poetry sent to her by friends.

Collection Contents

Series I: Correspondence, 1961–2024

This series contains correspondence sent to and from Sandra Berrigan, as well as third party correspondence related to Berrigan's marriage and family. Included in this series is the original correspondence between Sandra and her former husband, Ted Berrigan, written while Sandra was held in the Jackson Memorial Hosiptal mental ward from March to May of 1962.

Incoming 1962–2024

This sub-series contains correspondence received by Sandra Berrigan. Included in the materials are decades long correspondence with close friends including Ron Padgett, Maureen Owen, Anne Waldman, and Carla Harryman. Also included in this sub-series is correspondence from Sandra's former husband, Ted Berrigan, some of which is featured in the published book of their mutual correspondence from the early days of their marriage, *Dear Sandy, Hello*.
