Scope and Contents

The Sheldon Family papers document the history of Anne Dudley Sheldon Swift's (1916-2003) family. The papers come from both her father and mother's sides of the family, the Sheldons and the Coopers respectfully. Anne's family papers capture snapshots of life in Maine, Massachusetts, and Connecticut over several generations including significant moments in American history such as the Revolutionary and Civil wars.

Harrison Tweed Sheldon (1883-1933)--Anne's father--was born in New Haven, CT. He graduated from Yale University in 1905 and Yale Law School in 1908. Harrison married Alice Cooper Stanton (1879-1967) in 1915. The couple, and later their family, frequently took trips to the Katahdin region of Maine to camp, hike, canoe, and fish. Both Harrison and Anne are buried in the historic Grove Street Cemetery in New Haven, CT.

The Cooper branch of Anne's family includes the Savage and Tudor families. Papers relating to the Cooper family include correspondence between James S. Cooper and his father John Cooper; William Savage's journals documenting sea travel to the southern hemisphere; and official notes from the Committee of Correspondence for Boston, written by town clerk Reverend William Cooper.

The Sheldon branch of Anne's family includes the Tweed, Pond, and Jones families. Papers relating to the Sheldon family include correspondence between Theodore H. Sheldon and his family members including his wife Emily, and his brother Winthrop; military commission documents; and financial records for the family cattle business.

This collection is organized into two series: I. Correspondence, 1739-1917. II. Family papers, 1683-1945.
