Carl Frederick Schreiber (1886-1960)

Carl F. Schreiber was born in Saginaw, Michigan. His father, Hugo Friedrich, was a merchant; his mother was Adelaide Rueter. Schreiber received his B.A. from the University of Michigan in 1907, his M.A. from New York University in 1910, and his Ph.D. from Yale University in 1914. His dissertation, which remained unpublished, was entitled "Harro Harring: ein Beitrag zur Demagogenliteratur." After teaching German at an Illinois high school and at New York University, Schreiber came to Yale in 1909 as an instructor. By 1926 he had been promoted to full professor, and in 1928 he succeeded William A. Speck as curator of the William A. Speck Collection of Goetheana. In 1936 he was named the Leavenworth Professor of German Languages & Literatures. He retired from his faculty position in 1954 but stayed on as curator until his death.

Scope and Contents

The Carl F. Schreiber Papers consist of material generated by Schreiber as curator of the William A. Speck Collection at the Beinecke Rare Book & Manuscript Library and as a Yale faculty member. The bulk of the papers were left in the library when Schreiber retired; some material has been brought to the library by the Yale German Department and by occupants of the Palmer Schreiber Library in Bingham Tower. Material includes personal papers, correspondence, writing and research files, and writings by others, documenting Schreiber's research and curatorial activities which largely focused on the German authors Harro Harring and Goethe.

Schreiber's general professional correspondence is contained in the office correspondence of the Yale Collection of German Literature, where beginning in the 1940s it was interfiled with letters by Curt von Faber du Faur and Hedwig S. Dejon. Only letters strictly connected with specific projects and his correspondence relating to his research on Harro Harring and on Edgar Allan Poe have been classed here with his papers.

Arrangement

The collection is arranged into three series: I. Personal and family papers, circa 1912-1935. II. Writings and research projects, circa 1910-1957. III. Writings by others, circa 1930s.

Collection Contents

Series I: Personal and family papers, circa 1912-1935

(2 boxes)

Included are primarily scrapbooks and files relating to Schreiber's trips to Germany.

The scrapbooks contain newspaper clippings pasted in three columns per page. The clippings, dating from the 1890s, principally in German, some in English, are pasted on the pages of used ledger books of the 1870s from a business involving some sort of metered commodity. The prevalence of women's topics in the religion and poetry volumes suggests that the scrapbooks may have been compiled by a woman, possibly Schreiber's mother. A religious poem entitled "Take some part" near the end of the poetry volume is inscribed "Carl's recitative 1900."

The files documenting Schreiber's trips to Germany in the 1930s contain a variety of travel-related correspondence, programs, invitations, and post cards. In 1931 he appears to have carried the Speck Collection items illustrated in the Speck portfolio of 1932 and catalog of 1940 to Germany, where the facsimiles were produced. In 1932 (the centenary of Goethe's death) he gave a radio speech in Germany. The 1934 trip was a tour sponsored by the Carl Schurz Foundation for American educators and students. Schreiber's wife and daughter accompanied him in 1935.

Series II: Writings and research projects, circa 1910-1957

(10 boxes)

While Schreiber's doctoral research was on Harro Haring (1798-1870), he never published his dissertation on this radical writer and political agitator. His scholarly career and writing were instead devoted largely to Goethe, reflecting his association with the Speck Collection for some three decades.

Schreiber's research materials on Harro Haring are described in more detail than the rest of the papers. This section was described earlier for the information of the late Thomas Thode, whose Haring bibliography appeared in 2005.

As curator of the Speck Collection, Schreiber was deeply involved in two of its major publications, *Goetheana. A centenary portfolio of forty-three facsimiles and reproductions of unique or rare items from the William A Speck Collection of Goetheana*, and *Goethe's works with the exception of Faust: A catalogue compiled by members of the Yale University Library staff*, published by the Yale University Press in 1932 and 1940 respectively. The latter, conceived along the lines of the *Katalog der Sammlung Kppenberg* (2nd edition, Leipzig: Insel, 1928), was intended as a four-volume set, but no more was ever issued. (Volume 2 was to have described the collection's Faust holdings; volume 3 was to have contained biographical material about Goethe; and volume 4 was to have brought addenda and a much-needed index.)

The publishing history of the *Portfolio* and the *Catalogue* are bound together by the facsimiles contained in each. In 1931, Schreiber carried 43 items from the Speck Collection to Germany, where facsimiles were made by Albrecht Frisch, a printer in Berlin who specialized in photoengraving and who had worked on the catalog of the Kippenberg Collection. The facsimiles were produced in sets of 1,000 copies each. Five-hundred from each set were issued as the *Portfolio* in 1932; eight years later, the other 500 copies of seventeen of the facsimiles were bound into the first volume of the *Catalogue*. The other 26 sets of facsimiles have been preserved for years, and although the paper is now brittle and unsuitable to be bound in any book, the curator resisted various attempts to discard the remaining facsimiles. (She has distributed some of them in various ways as pertinent occasions arose, so most sets are incomplete.) Sets of the Frisch facsimiles in various formats are preserved in the Schreiber papers, along with correspondence about their production.

Also scheduled for publication in the centenary year 1932 was a proposed two-volume essay collection called "Goethe in America." In the mid-1920s Schreiber and his Yale colleague Adolph B. Benson began to collect papers and prepare them for publication, but in the end funds to print the book could not be raised. Seventeen papers are present in the collection, some of them by major scholars of the time, along with a file of correspondence, plans, and outlines.

Another scholarly project that came to naught was the so-called "Chicago" (later "Yale") Goethe. The history and background of this initiative is outlined in a letter from Victor Lange to Heinz Blum, dated 29 March 1954 in Box 10. In 1948, a group of scholars (Schreiber, Victor Lange, Arnold E. Bergraesser), anticipating the bicentennial of Goethe's birth, entered negotiations with the University of Chicago Press to publish a 4-volume edition of Goethe's works in new English translations. After some difficulties, documented in the collection by the example of Schreiber's translation of Goethe's *Novelle*, the University of Chicago Press transferred its contracts to the Henry Regnery Company, then also in Chicago; that contract is dated 1952. The arrangement with Henry Regnery apparently failed, and in 1954 Heinz Blum, chairman of the Yale German Department, attempted to revive the project as the "Yale" Goethe, to be published in 12 volumes by the Yale University Press. Financial subvention was promised by Frederick von Schleinitz, and the project seemed to be getting underway (without Schreiber's collaboration, however), but the documentation ends abruptly in 1957 and no volumes of "Yale" Goethe were ever published.

Materials in the Schreiber papers, although fragmentary, show that the translation of *Dichtung und Wahrheit* was well underway in the late 1940s: Minna Steel Smith's English version (London, 1908), itself based on the Oxenford/Morrison translation of 1849, was typed out in several copies and used as a basic text. Schreiber and his collaborators, Wallace J. Williamson and Jane Bannard Greene, made revisions. A version conflated from their various changes was being retyped and submitted to the University of Chicago Press. Not all copies for all sections of the book are preserved, but the typescripts present for Book

XIII illustrate the working process. The *Götz* translation may belong to the Yale phase of the project; that play is not listed in the University of Chicago Press contracts.

Schreiber's interest in Edgar Allan Poe dates to the summer of 1925, when he went to New York City to examine Superior Court records. While looking for documents relating to a suit that Harro Harring had brought against Harper and Brothers in 1846 (Harring, it will be remembered, was the subject of Schreiber's dissertation), he found instead the records of Poe's suit against the owners of the *New York Evening Mirror*, documents previously unknown to Poe scholars. Around this time Schreiber made Poe the focus of his personal book collecting: he set out to gather every book of which Poe had published a review, some 240 titles. Schreiber published at least two substantial articles about Poe: "A close-up of Poe" in *The Saturday Review of Literature* for 9 October 1926, and "Mr. Poe at his conjurations again" in *The Colophon*, 1930. The Schreiber papers retain other Poe materials, including Schreiber's essay "Poe and Goethe," which is related textually to "Mr. Poe at his conjurations again." Schreiber seems also to have devoted a good deal of research to prove Poe's role in the compilation of *The Laws of Etiquette* (Philadelphia: Carey, Lea, and Blanchard, 1836) and on an essay called "The Canon of Good Breeding."

A small convolute of typed transcriptions concerning the composer Robert Lucas Pearsall from well-known periodicals and reference books was discarded; Schreiber's interest in Pearsall may have been due to the fact that Pearsall made an attempt to translate *Faust*.
