The original inventory lists these records as "Campus Police History Project (JFF File)." JFF is probably Jonathan F. Fanton, Special Assistant to the President, who was a member of the Police Advisory Board. The records include crime reports, crime statistics, policies, correspondence, annual reports, arrests and incident reports concerning matters dealt with by the Police Advisory Board. Materials in these files are primarily addressed to Richard Carroll, Chair of Police Board, Henry Chauncey, Jr., Special Assistant to the President and Chair Police Board, and Jonathan Fanton.

The records consist of reports, correspondence, agendas and meeting minutes of the Police Advisory Board, crime stats, and budgets. Reports, crime states, and budget materials seem to have been sent directly to the Secretary.
