**SUMMARY:** Correspondence, financial records, and memorabilia of this Stamford, Connecticut family. The principal figure is David Waterbury (1722-1801), who served as a colonel in the French and Indian War and again in the American Revolution. Included in the papers are military records relating to these events and a letter to him from Roger Sherman (1776 Apr 30) about a Continental Commission. Also two travel journals kept by his son, William Waterbury IV, one for a trip through New York, Pennsylvania, Virginia, Kentucky, Maryland and Delaware in 1799-1800 and another for a trip through New York State in 1812-1813.

## Biographical / Historical

David Waterbury (1722-1801): military officer; served in six campaigns in the French and Indian Wars; appointed Brigadier General, 1776; served 23 successive terms as Stamford representative in the Connecticut legislature.

---

## Scope and Contents

This collection consists of correspondence, financial records, and memorabilia of the Waterbury family of Stamford, Connecticut, and of military papers belonging to David Waterbury (1722-1801). Included among these is an orderly book (1758-59) and orders for Brigadier General Benedict Arnold at Ticonderoga (1776 Aug 7). The correspondence contains both family and general letters, the most interesting being a letter from Roger Sherman to David Waterbury concerning a Continental Commission (1776 Apr 30). The financial and legal papers of the family include an indenture from 1700, account books, and deeds, while the highlight of the memorabilia is a series of diaries kept by William Waterbury IV (the son of David Waterbury) during travels through New York, Pennsylvania, Virginia, Maryland, and Delaware in 1799-1800 and New York in 1812-13.
