Biographical / Historical

Alexander O. Vietor (1913-1981): associate of naval architecture firm of Cox & Stevens in New York, 1937-1940; in 1941 became assistant to Yale University director of Art Gallery; in 1943 named curator of maps at Yale; from 1948-1950, secretary of Yale Council on Libraries and Museums.

Scope and Contents

The collection consists of ships' logs, nineteenth-century cargo manifests of Connecticut ships on fishing voyages, and the papers of ships sailing to the West Indies for rum and sugar and to the Antarctic on sealing expeditions. Also included are miscellaneous legal documents related to ships and shipping and a group of ten letters to Captain George W. Lee or to members of his family (1811-1833).
