Also in the collection are circa two thousand postcards showing World War I naval scenes and photographs of American transports.

Biographical / Historical

Langhorne Gibson graduated from Yale College with the Class of 1922. He was apprenticed with the Crowell Publishing Company in New York City, and was author of *Death of a Fleet* and *The Riddle of Jutland*. Gibson's hobbies were hunting and yachting, and he designed and built Diana, a motor-sailer on which he and his wife lived during the first year of their marriage. He married Parthenia Ross in 1936 and they had seven children.

Scope and Contents

The papers consist of pamphlets and other printed matter with some letters, diaries and manuscripts relating to naval affairs. The largest block of material concerns World War I, particularly the questions of the German naval mutiny of 1917, the surrender of the German fleet in November 1918, and the scuttling of its most important units at Scapa Flow in 1919.
