SUMMARY: The papers consist of correspondence, bills, research materials, and topical files which document the political career of Ebenezer J. Hill, a United States Congressman from Connecticut, 1895-1913 and 1915-1917. Correspondence files contain constituent mail regarding requests for publications, political appointments, favors, and suggested votes on pending legislation. Frequent topics are military pensions, banking issues, currency matters, and U.S. Post Office appointments in Connecticut.

Biographical / Historical

Ebenezer J. Hill was born in Redding, Connecticut on August 4, 1845. He attended Yale College (Class of 1865) and served in the U.S. Army in a civilian capacity in 1863. Hill was a businessman and politician in Norwalk, Connecticut. He was elected to the U.S. Congress and served from 1895-1913 and 1915-1917. He died in 1917.

Scope and Contents

The Ebenezer J. Hill Papers consist of correspondence, bills, research materials, and topical files which document the political career of Ebenezer J. Hill, a Connecticut congressman from 1895-1913 and 1915-1917. Span dates for the papers are 1884-1911, with the bulk of material dating from 1895-1911.

The papers are arranged in two series. SERIES I, Correspondence, 1884-1911 contains letters to and from constituents on a variety of topics including: requests for publications, political appointments, and favors. Other frequent topics are: military pensions, banking issues, currency matters, pending legislation, and the subject of U.S. Post Office positions (postmasters) within Hill's congressional district. Prior to 1900, only letters to Hill are available in the papers. After 1900, however, carbon copies of replies often remain with incoming letters.

SERIES II, Topical Files, 1900-1907, consists of correspondence, notes, and other material which document selected areas of interest for Hill and his constituents. Among these topics are: pensions, post office matters, and the eight-hour work day.
