SUMMARY: Chiefly correspondence and legal papers of the law firm founded in New Haven by Henry White's father, Dyer White, in 1785. Henry White joined the firm in 1828. Records of 113 individuals, firms, and estates whose business the firm handled make up the business section of the papers. Also included are a small amount of Dyer White's family correspondence (1784-1836) and college lecture notes, account books related to church activities (1822-1837), and other miscellaneous papers of Henry White.

Biographical / Historical

HENRY WHITE, the only surviving child of the Hon. Dyer and Hannah (Wetmore) White, was born in New Haven, Conn., March 5, 1803.

He received his BA from Yale in 1821. From 1823 to 1825 he served as a tutor at Yale. He then studied law, and entered on its practice in 1828 in his native city, where he continued to reside until his sudden death, from neuralgia of the heart, Oct. 7, 1880, at the age of 77. His tastes led him to appear rarely in court, but he was specially occupied with the settlement of estates and the care of trust funds, and in these duties had the entire confidence of the community through a long life. He was also much interested in matters of local history and had given particular attention to the compilation of a history of the ownership of land in New Haven. He was one of the founders and the first president of the New Haven Colony Historical Society. For nearly half a century he was a deacon in the Center Church. He was married, Jan. 7, 1830, to Martha, daughter of Roger Sherman, of New Haven, and granddaughter of the Hon. Roger Sherman. She survived him with six sons, graduates of this College in 1851, 1854, 1859, 1860, 1864 and 1866, a seventh son having died a few months before his father.

Scope and Contents

The Henry White Papers, 1745-1886, consist of 6.5 linear feet of business, legal, and personal papers from the offices of Henry White, lawyer of New Haven. This firm, founded in 1785 by his father, Judge Dyer White (1762-1841), became White Brothers in 1880, when Henry White died, leaving the business to his sons. The papers are mainly those of individuals, firms, and estates whose business the firm handled. Also included are some papers of Dyer White as New Haven officeholder, some personal letters, and several lectures delivered by Henry White at Yale College and before the Mechanics' Society and the Young Men's Institute.

The Henry White Papers came to the Library from Roger S. White, from the White law offices, and from a Mr. Sanborn between 1913 and 1925.
