Biographical / Historical

Edgar L. Heermance received his undergraduate and graduate degrees from Yale (B.A., 1897; M.A., 1899; B.D., 1901). After serving for seventeen years as a minister and frontier missionary in Minnesota, he returned to New Haven in 1919 and devoted himself to study and writing. Beginning in 1936 he was also active in New England forestry, serving as an officer of several trade and environmental organizations. These are his major publications:

1906 --*Democracy in the Church*

1915 --*The Unfolding Universe*

1922 --*Chaos or Cosmos*

1926 --*The Ethics of Business: A Study of Current Standards*

1933 --*Can Business Govern Itself?*

1935 --*The Connecticut Guide*

1942 --*The Time Stream: A Voyager Takes a Reckoning*

The 1897 Yale class books contain excerpts from his letters to the class secretary and more information about his career.

Scope and Contents

The Edgar L. Heermance Papers consist mainly of correspondence, writings, and printed matter accumulated through hundreds of inquiries to business and professional associations about ethics (mainly 1924-1925) and economic planning (mainly ca. 1933). The result is an extraordinary collection of printed codes of ethics and printed and manuscript statements about business plans and practices. Heermance used this material to prepare books on these subjects and then donated it to Yale in 1937. The arrangement is alphabetical by business or profession, as listed on the following pages.

There is also a typescript autobiography of Heermance that spans from his childhood to his ministry in Minnesota.
