# Biographical / Historical

David Andrew Hunter was born on March 24, 1904 in New Orleans, Louisiana. He graduated from Warren Easton High School in 1921. He studied for one year at Tulane University and eventually worked at Kessler Insurance Company in New Orleans. He married Belle Watson in 1930. Their son, David Andrew Hunter, Jr. was born in 1931. David Hunter, Sr. enlisted in the Army on June 23, 1942 in New Orleans. As an Intelligence Officer in the Office of Strategic Services, Hunter served in Burma, India, China and Thailand. Hunter received an honorable discharge on April 6, 1946, and returned to New Orleans. Thereafter, he became ill with dysentery and malaria. He attempted to prove his illness was service-related in order to receive compensation, but was unsuccessful. David Andrew Hunter died on May 19, 1958.

## **Scope and Contents**

The papers consist of correspondence, topical files and photographs. Correspondence and topical files document David Hunter's attempts to prove that his post-war illnesses were service-related and to gain compensation. The photographs are of the Far East during World War II.

The papers are arranged in three series: Series I. Correspondence, 1942-1958. Series II. Topical Files, 1942-1958. Series III. Photographs, 1958, undated

### **Collection Contents**

## Series I: Correspondence, 1942-1958

Correspondence is arranged in two sections: "Family" and "Other." Within each section, letters are arranged chronologically. The "Family" section contains letters written by Hunter to his wife and son during his service in World War II. The letters reveal very little about the course of the war or Hunter's role in it. Hunter comments mainly on family matters and foreign culture and landscapes. The "Other" section primarily includes letters written by non-family members on behalf of Hunter in his attempt to gain compensation for his illnesses. Typically, the writers address the capacity in which they were familiar with Hunter and praise his character. Copies of Hunter's solicitations for such assistance are frequently attached.

### Series II: Topical Files, 1942-1958, undated

This series is arranged alphabetically. Most materials relate to Hunter's medical problems and attempts to obtain compensation from the Red Cross, Social Security Administration and Veteran's Administration. The "Medical record" file is the most informative pertaining to his illnesses. "Military record" provides extensive biographical information. "Memos and directives" includes information on Hunter's military transfers and duties. "Prisoners of War, Siam" contains a draft by Hunter of a work that describes the American prisoners of war he evacuated from Siam in August, 1945.

### Series III: Photographs, 1958, undated

Photographs are arranged in two sections: "Identified" and "Unidentified." Within these sections they are arranged alphabetically by topic. The majority are undated. They are comprised of black and white photographs,  $2" \times 3.5"$ ,  $3" \times 5"$ , and  $8" \times 10"$ . On the whole, the photographs are in good condition, but some have faded. A few of the 8" by 10" photographs are of superior quality. This is the most interesting series in the collection. It contains hundreds of photographs of the landscape, culture, indigenous peoples and American soldiers in the Far East during World War II.
