### Biographical / Historical

C. Ray Smith was an architectural writer and critic based in New York City. He received a master's degree in architecture from Yale in 1958. He authored several books on architecture and design, and was an editor of many prominent architectural publications, including *Progressive Architecture*, *Interiors*, and *Oculus*. He died in 1988.

# **Scope and Contents**

The collection includes correspondence, research notes, recorded interviews and interview transcripts, and drafts of C. Ray Smith's unpublished manuscript, entitled *The Biography of a Building: Paul Rudolph's Art and Architecture Building at Yale*. It also includes site and structural information about the building itself, as well as a questionnaire for Yale School of Architecture alumni, designed by Smith, regarding their impressions of the building. Some materials in the collection have sustained water damage.

Interviews with architects and others affiliated with the construction of the Art and Architecture Building

The interviews with architects and others affiliated with the construction of the Art and Architecture Building consist of audiocassettes recorded by Smith. The labels on the cassettes were handwritten by Smith and are occasionally illegible. Labels are transcribed as written, with notations by the archivist, where applicable, in brackets. Where two dates for a cassette are listed, the first indicates the date of side 1, followed by the date of side 2.

Original audiovisual materials, as well as preservation and duplicating masters, may not be played. Researchers must consult use copies, or if none exist must pay for a use copy, which is retained by the repository.
