## Biographical / Historical

Edith Mirante was born in Newark, New Jersey and graduated from Sarah Lawrence College in 1975. Since the early 1980's, she has been actively involved in collecting and disseminating information on Burma (Myanmar), specifically regarding environmental and human rights conditions, specializing in the conditions among the Kachin, Chin, Rakhine, and Rohingya ethnic groups from Burma's northern and western frontiers. Mirante is the author of reports, popular media and encyclopedia articles, book chapters, and three monographs as of 2015 on Burma, Southeast Asia, human rights, and deforestation. She exposed the misuse of the herbicide 2,4-D in a US anti-narcotics program in Burma during the 1980's, and has testified on the country before the US Congress, European Trade Commission, and the International Labor Organization. She has also spoken at national conferences of Amnesty International USA and Rainforest Action Network, and for numerous environmental, human rights, and women's groups.

Mirante is the founder and director of Project Maje, an independent project that has been responsible for disseminating information on human rights and indigenous and environmental issues in Burma since 1986.

## Scope and Contents

The contents of the Project Maje collection reflect the professional and research interests of human rights advocate and author Edith Mirante, and draw upon more than three decades of her work in and on the border regions of Burma (Myanmar). The term "Maje" refers to a bell venerated by the Apatani tribe of Arunachal Pradesh, India. This term was chosen for its symbolism and to avoid implications of ethnic favoritism in a country fraught by ethnic and religious violence. Its pronunciation is similar to that of the term for "older sister" in Burmese, which is a positive association as older sisters look after younger siblings.

The bulk of the materials center on issues of human rights and indigenous communities in Burma's northern and western frontiers; petroleum multinationals, deforestation, and environmental issues; and more general documents attending to the Burma's tumultuous political context.

## **Arrangement**

The collection is organized into eleven series according to content and format type: I. United States and Asian press, government reports, and documents, II. Newsletters, press, documents, and women's issues, 1989-1995, III. Newsletters, press, documents, and Project Maja reports, 1996-1997, IV. Assorted documents, V. Arakan, Rohingya, Chin, and Kachin documents, 2005-2007, VI. Unocal pipeline materials, VII. Corporate, resource extraction, and environmental issues, VIII. Press binders and tourism issues, IX. HIV/AIDS, X. Posters, calendars, drawings, and XI. Video cassettes.

## Collection Contents
